

## Owner Agreement- Liability Release and Policies

I, \_\_\_\_\_ (owner), hereby certify that my dog(s) \_\_\_\_\_, is/are in good health and have not been ill with any communicable condition in the last 30 days. I further certify that my dog(s) have not harmed or shown any aggressive or threatening behavior towards any person or any other dog.

Riverside Veterinary Hospital Dog Day Care agrees to exercise due and reasonable care in the handling of dogs, and in keeping the facility properly enclosed and sanitary. Proper care will be taken to not expose dog(s) to harmful situations. Dogs will not be left unattended outside.

I have read and understand the following:

1. I understand that I am solely responsible for any harm caused by my dog(s) while my dog(s) is/are attending dog day care, and release Riverside Veterinary Hospital of any liability arising from my dog(s) attendance and participation at the daycare.
2. I recognize that there are inherent risks of illness or injury when dealing with animals. Such risks include, but are not limited to, problems resulting from rough play, altercations and illnesses.
3. I further understand and agree that admitting my dog(s) to dog day care, the staff here at Riverside have relied on my representation that my dog(s) is/are in good health and have not harmed or shown aggressive or threatening behavior towards any person or any other dog.
4. I understand that my dog(s) will be playing in open areas with other dogs and accept that when dogs play in group, injuries may occur. I further understand that the staff and volunteers at Riverside Veterinary Hospital will not be liable for any problems which develop provided reasonable precautions are followed.
5. I further understand and agree that any problems which develop with my dog(s) will be treated as deemed best by the staff and volunteers, at their sole discretion, and that I assume full financial responsibility for any and all expenses involved if I or Riverside decides to obtain medical treatment.

**Fees:** Fees are based on a daily or pass plan and are due upon departure of pet's scheduled visit. A pass can be purchased for (1) single day, 10 days or 20 days.

**Days and hours:** Monday through Friday, 7:30am to 6:00pm. Please have your pet picked up by 6:00pm. This is when Riverside Veterinary Hospital locks its doors.

**Reservations:** Please let us know you are coming to day care. This helps us plan for activities and staffing.

Emergency: In the event of an emergency, Riverside Veterinary Hospital staff will first attempt to contact the owner, followed by other emergency contact listed on file. Our staff retains sole discretion in emergency matters without liability.

I certify that I have read and understand the policies of Riverside Veterinary Hospital Dog Day Care, as set forth on this agreement, and that I have read and understand the conditions and statement of this agreement.
