I further understand that the staff and volunteers at Riverside Veterinary Hospital (RVH) will not be liable for any problems which develop provided reasonable precautions are followed. I hereby release Riverside Veterinary Hospital of any liability from my dog(s) attendance and participation at daycare.
- 2. I recognize that there are inherent risks of illness or injury when dealing with animals. Such risk include, but are not limited to, problems resulting from rough play, altercations and illnesses.
- 3. I further understand and agree that admitting my dog(s) to dog day care, the staff here at Riverside have relied on my representation that my dog(s) is/are in good health and have not harmed or shown aggressive or threatening behavior towards any person or any other dog.
- 4. I further understand and agree that any problems which develop with my dog(s) will be treated as deemed best by the staff and volunteers, at their sole discretion, and that I assume full financial responsibility for any and all expenses involved if I or Riverside decides to administer medical treatment.

<u>Medical Requirements:</u> Pets participating in daycare must be at least four months of age and be vaccinated against Rabies, Distemper/Parvo, Bordetella, and Canine Influenza. Pets should also be on monthly flea and tick prevention.

Pets over the age of six months must be spayed or neutered.

<u>Fees:</u> Fees are based on a daily or pass plan and are due upon departure of pet's scheduled visit. A pass can be purchased for a whole or half day (1) single day, 10 days or 20 days.

<u>Days and Hours:</u> Doggie Daycare is available Monday through Friday. Pets may be dropped off as early as 7:30 AM and must be picked up by 6:00 PM.

Reservations: Please let us know you are coming to day care. This helps us plan for activities and staffing.

<u>Emergencies:</u> In the event of an emergency, Riverside Veterinary Hospital staff will first attempt to contact the owner, followed by other emergency contact listed on file. Our staff retains sole discretion in emergency matters without liability.

<u>Photo/Video Release:</u> I give Riverside Veterinary Hospital permission to use my pet(s) picture, or video, for publicity/advertising/web content/social media pages.
